### **A Local League Position Gets Results**

If you've always been interested in being more involved in local government, applying for a post on a city of Fargo board or commission just got easier.

Fargo has updated and expanded its web site. The site now includes a page that offers citizens the chance to apply for membership on city boards and commissions electronically. The Getting Involved web page ([www.cityoffargo.com/getting-involved](http://www.cityoffargo.com/getting-involved)), explains the functions, meeting times, etc. of the various city boards and commissions that accept citizens' applications for membership. It also includes an application form that can be completed online and gives users the ability to send in their resume electronically.

At its 2002 Annual Meeting, the LWVRRV adopted a position on local boards and commissions. Among other suggestions, the position contains the following statements:

*The LWVRRV supports an open appointment process to the boards and commissions which serve our community.*

The citizenry can be encouraged to participate through:

- Use of a formal application form.
- Use of the City Web sites to explain the application process and provide online application forms.

When announcing the creation of the new Getting Involved web page, Fargo Mayor Bruce Furness said, "We appreciate the suggestions of the League of Women Voters on how we can make it easier for citizens to take part in their government."

If you would like to be considered for an appointed position with the city of Fargo, now you can fill out your application online and it will be kept and considered as openings occur in the future.

## **WVRRV Board News...**

### **New Board Members**

#### **Peggy Jensen**

I joined the LWV in 1980 and was very active in both the Porter County, Indiana LWV (Pres., V.P., Voter Editor, Voters Service, etc.) and the Indiana State LWV (Board Member, Voter Co-Editor). I've been out of the country for the last 8 years and am anxious to get involved in LWV again. I'm looking forward to helping increase our visibility in the local area and to help develop and promote our First Friday Program Series.

#### **Nicole Bergeron**

I was first introduced to the League in college. Suzanne Dobbins and Barbara Headrick explained the mission of the organization and encouraged me to get involved. I believe strongly in the principles of the League and very much wanted to be a part of it. While on the board, I hope to help increase the understanding and participation of the democratic process in our region.

### **Board Briefs**

The Board of the LWVRRV held its annual planning meeting July 16th. One topic that was discussed was the need in the community for some sort of concise guide to local government. People in the community often are not sure of where to go and who to contact when they have a problem or concern that local government could address.

The Board agreed that this was a project that the League could undertake, with the help of other local agencies.

## Observer Corps

### Fargo School Board

On June 10, the School Board voted to approve the third draft of the Long-Range Facility Plan which included almost all the recommendations from the community planning task force except the establishment of criteria for closing old facilities and building new ones.

Important features of the plan include the acceptance of the following configuration model:

- Grades K-5 in elementary schools,
- 6-8 in middle schools, and
- 9-12 in high schools throughout the city.

In order to move forward with this plan, replacement of the current Agassiz Middle School facility, extensive remodeling of Discovery School and the eventual construction of a new elementary school in the southwest would be required along with other adjustments. The time line discussed at this time was ten years. The Board Briefs (6-10-03) state that "both the time line and the pathway to achieve the vision may be revised due to demographic changes or other issues."

The criteria for closing old or building new schools was discussed by the board in a work session held on July 8. The Fargo City Planning Commission and staff provided input. The board appears to be moving slowly on this potentially heated area of the planning process. City Planner Jessica Thomasson will be invited to an upcoming meeting to discuss "revitalization initiatives." The closing/construction criteria will be revised by Lowell Wolfe to include points raised in the board discussion.

At the August 12 board meeting, speedy action toward the fulfillment of the long-range plan commenced with approval of the purchase of land for an eventual elementary school on the corner of 42nd St. S. and 44th Ave. SW. The Fargo Park Board will co-own the property contributing half the purchase price and part of the tax bill. (Forum, 8-13-03). The Forum article mentions that the long-range plan includes a projected date of 2007 for the new elementary school and the new middle school, which would be considerably inside the ten year time line mentioned above.

### Fargo City Commission

The Fargo City Commission room, as well as the Mayor and Commission offices, are now located in the second floor area above the new addition to the Civic Center. The Commission held its first meeting in the new facility on August 4th. The much improved sound system and audio-visual capabilities should make Commission meetings easier to follow for those attending in person or watching on cable television. The room also has four times the capacity of the old chamber. In the past, when more controversial issues were to be discussed, City Commission meetings were often standing room only.

### Making It Easier To Vote

Leagues across the country have been following implementation of HAVA...the Help America Vote Act...passed by Congress in 2002.

Resulting from the year 2000 voting problems in Florida, HAVA is more than just getting new voting machines. Each state is required to:

- Provide voters an opportunity to check for and correct ballot errors in a private and independent manner.
- Have a voting system with a manual audit capacity.
- Provide at least one voting machine per precinct that is disability accessible.
- Provide alternative language accessibility pursuant to the Voting Rights Act.
- Have a voting system whose error rate does not exceed the existing rate established by the FEC Office of Election Administration.
- Define what constitutes a legal vote for each type of voting machine used in the state.
- Provide provisional ballots to ensure no individual is turned away at the polls.
- Implement a uniform, centralized, computerized, statewide voter registration database to ensure accurate lists.

Both Minnesota and North Dakota have made their plans available for public review. LWVMN has a letter to the MN Secretary of State on their website outlining some concerns with the Minnesota plan. LWVMN asked whether the new machines will be capable of adapting to new election systems such as ranked and cumulative voting processes.

Come to the September First Friday (in the Dawson Lounge at the YMCA) to hear how the 2004 elections may be different than in the past. Speakers include Mike Montplaisir, Cass County Auditor, who serves as chair of the ND

HAVA Planning Committee and Clay County Auditor Lori Johnson who will answer questions on procedures in Minnesota. You will hear about DREs (direct response electronic) voting machines, EDR (election day registration), provisional ballots, "second chance" voting, and VVPBs (voter verifiable paper ballots). You won't want to miss this meeting.
