## Lunch with Leaders

The LWV has always been a way to develop leadership, to be active in our communities, businesses, and the wide variety of government offices. To further that goal, the League initiated Lunch with Leaders. Lunch guests have an opportunity to meet others who have a broad experience as leaders. They can network, look for ways to broaden their experiences and build their resumés, and find mentoring opportunities.

The featured speaker at the second annual LWVRRV Lunch with Leaders event will be Heidi Heitkamp. Her experience as a political leader, professional, and volunteer is well known.

Heidi Heitkamp is a lawyer and politician from North Dakota. She was ND Attorney General from 1993 to 2001. She is currently spearheading the Laurie J. Loveland lecture series at North Dakota State University.

While serving as ND Attorney General, one of Heitkamp's biggest achievements was working with Laurie Loveland on the lawsuit filed against big tobacco. She helped lead the campaign to hold big tobacco companies responsible for their actions and succeeded in obtaining large amounts of money for each state to use in tobacco cessation programs. The lawsuit also placed restrictions on allowable advertising for tobacco companies.

The **Lunch with Leaders** event will be held September 20 at 11:30 a.m. Marriott Convention Center in Moorhead. Registration is \$25 and includes a buffet lunch.

## North Dakota Redistricting Reform Initiative

At the May 25, 2010 meeting the Board of the North Dakota League of Women Voters voted to sponsor a constitutional amendment initiated measure that, if passed, would create an independent legislative redistricting commission for North Dakota.

As an organization that is dedicated to the principles of nonpartisanship, representative government and citizen involvement in public policy, the League of Women Voters is the ideal group to promote such an initiative for redistricting reform.

As long as new legislative district boundaries are set by the Legislature, gerrymandering is apt to occur. An independent commission would be more likely to draw district lines based on communities of interest and geographic features and would be less biased by the political affiliation of the voters. Elections would be more competitive, and the voters would be more engaged in the process.

In order for the citizens of North Dakota to have a chance to vote on this initiated measure, petitions must be circulated and signed. Although we were not able to get onto this November's ballot, signatures can still be collected on the petitions until June of 2011 and the measure will then be on the 2012 ballot.

Several League members collected hundreds of signatures at a booth at the Red River Valley Fair in July 2010. There are plans to have booths at other events in upcoming months, such as the Winter Show in Valley City. Many interested people all over the state have already returned filled petitions to the League office and are continuing to collect signatures.

**Of course, the more people who circulate petitions, the better the chances of this important initiative making it to the North Dakota ballot. If you would like to help, go to the [www.lwvnd.org](http://www.lwvnd.org) website where there is a link to download and print your own copy of the initiative.**

Any eligible North Dakota voter may sign a petition, (although a person may not sign a petition that he or she is carrying). Get as many signatures as you can, take the petition to a notary public and have your signature notarized on the last page of the initiative.

Then mail the entire document to the state League office:

## First Friday parking at the S.O.N. parking lot


**Members:** Cut out this Parking Permit and use during each LWV meeting to park in the Sons of Norway parking lot.
